Weekly Tuition Rates (As of 08/04/2025)

Infants & Toddlers **\$275***

Preschool (K-2) **\$250***

Preschool (K-3 & K-4) **\$235***

Included in full-day programming are all books and teaching curricula, as well as most special activities. Grace Café provides a hot breakfast, lunch, and afternoon snack.

*Included in the weekly tuition rate above is a \$20 Capital Facility Fee. This fee covers the regulatory-required facility changes as well as the acquisition, upgrades, and expansion of our facilities. This fee is set aside for special use in regard to property and building projects needed to sustain the ministry of Grace Christian Child Development Center.

Application Fee: (Non-refundable) \$250 per new student. Due at the time of application. Note: If there is a waiting list, those who have fully applied and paid the application fee will be prioritized for space.

Enrollment Fee: (Non-refundable) \$325 per new student. Due at the time of enrollment.

Re-Enrollment Fee: (Non-refundable) \$200 per returning student during Closed Enrollment March 7th – 24th, 2025. Beginning March 25th, 2025, the late re-enrollment fee increases to \$400 per returning student. Failure to re-enroll during closed enrollment may lead to your student's seat being unavailable. Due at the time of enrollment.

Additional Fees as Applicable (Non-Refundable) Access Badge \$25,
K-4 Graduation Fee \$50, K-4 Preschool Field Trip Fee \$100, Transportation (varies)

K-4 Half-Day Annual Tuition: \$6250 (monthly payment plan is required)
Half-day programming operates from 7:30 AM to 11:30 AM. Children can be dropped off after 7:00 AM & must be picked up by 11:30 AM. The half-day program provides breakfast, books, and curriculum. This program operates in coordination with the Grace Christian School calendar. Note: priority enrollment is given to full-day students.

Payment Policy

Late Payments: Grace CDC operates as a non-profit and depends on timely payments. A **\$65 late fee** will be charged for late payments in addition to return payment fees incurred by FACTS. Failure to pay as agreed will lead to the interruption of enrollment for your student.

Automatic Payment Method Required: All Grace Christian Child Development Center billing and payments are processed through FACTS via the automated payment method of your choice. All families must have a valid and active payment method on file for both payment plans and incidental charges.

If at any point your automatic payment method becomes invalid/inactive, a \$100 fee will be assessed each month until a valid and active payment method is re-established.

Withdrawal Policy

Parents may withdraw a child at any time. A two-week notice is required, and the submission of the withdrawal form confirms the withdrawal date. Parents who fail to provide a two-week notice will remain liable for two week's tuition and fees. Fees to include, but not limited to, Application and Enrollment fees are non-refundable.
